URGENT PLEASE REPLY FOR YOUR INFORMATION PLEASE REVIEW

Effective June 1st 2008, The Market Rules of the Adelaide Produce Markets will be amended as follows:

1 In the definition section there will be added the following definitions:

- 1.16A Market Days means Monday, Wednesday and Friday, other than public holidays
- 1.20A Non Market Days means Tuesday, Thursday and Saturday, other than public holidays.
- 1.19A Movement of Produce means the movement of Produce within the Market from:

- 1.19A.1 One Wholesaler to another,
- 1.19A.2 a Wholesaler to a Grower or Grower Agent,
- 1.19A.3 a Wholesaler to a Buyer,
- 1.19A.4 a Wholesaler to a warehouse facility which is in the possession of a Buyer,
- 1.19A.5 a Grower or Grower Agent to Wholesaler,
- 1.19A.6 a Grower or Grower Agent to a Buyer, or
- 1.19A.7 a Grower or Grower Agent to a warehouse facility which is in the possession of a Buyer, and

excludes produce being unloaded by the official unloader or unloading service for the Market

Effective 1st June 2008

- 2 Rule 2.1 will be deleted and replaced by a new Rule 2.1 which will read as follows:**
- 2.1.1 On Market Days there will be no Movement of Produce from 12.00am to 3.00am.
 - 2.1.2 On Market Days, from 3.00am to 3.30am, the only Movement of Produce which shall be permitted shall be from:
 - 2.1.2.1 one Wholesaler to another,
 - 2.1.2.2 a Wholesaler to a warehouse facility which is in the possession of a Buyer,
 - 2.1.2.3 a Grower or Grower Agent to a Wholesaler,
 - 2.1.2.4 a Grower or a Grower Agent to a warehouse facility which is in the possession of a Buyer
 - 2.1.3 On Market Days, in the period from 3.30am to 5.30am, there shall be no restrictions on the Movement of Produce, other than no person will be permitted to take Produce out of the Market .
 - 2.1.4 On Market Days after 5.30am, there shall be no restrictions on the Movement of Produce.
 - 2.1.5 On Market Days, within the Market, from 12.00am to 3.30am, no person shall buy, offer to buy or invite offers to sell Produce, and no person shall sell, offer to sell or invite offers to buy Produce, or otherwise trade in Produce.
 - 2.1.6 On Non Market Days there will be no Movement of Produce from 12.00am to 5.00am, and in that period no person shall buy, offer to buy or invite offers to sell Produce, and no person shall sell, offer to sell or invite offers to buy Produce, or otherwise trade in Produce.
 - 2.1.7 On Non Market Days, from 5.00am to 5.30am, the only Movement of Produce which shall be permitted shall be from:
 - 2.1.7.1 one Wholesaler to another,
 - 2.1.7.2 a Wholesaler to a warehouse facility which is in the possession of a Buyer,
 - 2.1.7.3 a Grower or Grower Agent to a Wholesaler,
 - 2.1.7.4 a Grower or a Grower Agent to a warehouse facility which is in the possession of a Buyer
 - 2.1.8 On Non Market Days, after 5.30am, there shall be no restrictions on the Movement of Produce.
